## **ONLINE ADMISSION INSTRUCTIONS**

As per instructions of Haryana Govt. conveyed vide letter No. DHE-010019/6/2020-Coordination DHE dated 14.07.2022 by Director General Higher Education, Panchkula, admissions to PG Programmes in Affiliated Degree Colleges are to be conducted through affiliating Universities. The following points are for consideration of all concerned:

- 1. Applicants should regularly check CRSU, Jind and college website for updates.
- 2. Merit list (I, II, III) will be provided to colleges (as per choice made by applicant) Programme and category wise.
- 3. Colleges will display the list of Programmes offered, intake, division of seats and fee structure of the P.G. Programmes on their respective websites.
- 4. Consolidated result of all semesters or grand total in a qualifying exam will be considered. Incomplete result or tentative marks will not be considered.
- 5. Scanned copy of provisional marksheet may be uploaded as evidence of marks in qualifying class. However, original DMC will be required during document verification.
- 6. Colleges should constitute their own Admission Committee, Grievance Redressal Committee and helplines.
- 7. After making admission from 1<sup>st</sup> merit list, latest position (Programme and category-wise) must be uploaded by each College. The same will be applicable for subsequent lists.
- 8. Merit list will be sent by CRSU, Jind (as per choice made by the candidate) to affiliated colleges.
- 9. Supporting documents shall be checked/ verified by the college concerned before confirmation of admission.
- 10. Step-wise filling of application form/ manual is available on the University website.

  College website will also display the manual.
- 11. A whatsapp group of admission committee of affiliated colleges & University officials is being created for smooth functioning of admission process.
- 12. We request your active participation and unflinching support.
